System of Arrangement

Documents responsive to this FOIA were found in these collection areas – Obama Presidential Electronic Records

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home

and shared drives used by White House staff.

Container List

The following is a list of documents, folders, and electronic search results lists (SRLs) that were processed in response to FOIA 23-13507-F:

Electronic Records

- *Christensen* contains 11 assets, of which 11 are withheld in part.
- *NSC* contains 2 assets, of which 2 are withheld in full.

- *Tillerson* contains 20 assets, of which 20 are withheld in part.
