The materials in FOIA 22-18463-F are a selective, not necessarily all-inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 22-18463-F requested materials related to any and all documents, texts, emails, voice recordings, call logs and Visitor Logs, communications and meetings between Justice Roberts and President Obama.

This FOIA primarily contains event memos, speeches, and newsletter drafts. The bulk of the electronic records proposed for release are related to President Obama meeting with Supreme Court Justices at Justice Sotomayor's Investiture ceremony, President Obama's Inauguration oath of office with Chief Justice John Roberts and President Obama's speech at the Dedication Ceremony for the National Museum of African American History and Culture.

System of Arrangement

The materials in FOIA 22-18463-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – Obama Presidential Electronic Records

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
