Scope and Content Note

The materials in FOIA 22-17671-F are a selective, not necessarily all-inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 22-17671-F requested materials related to emails, letters, memos, presidential correspondence, transcripts of national security briefings held for President Barack Obama and audio clips mentioning or referring to Donald Trump and his presidential campaign.

This FOIA primarily contains memos, spreadsheets, and email correspondence from January 1, 2016 to March 31, 2016.

System of Arrangement

The materials in FOIA 22-17671-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – Obama Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the

White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

Container List

The following is a list of documents, folders, and electronic search results lists (SRLs) that were processed in response to FOIA 22-17671-F:

Electronic Records

- *CEA* contains 129 assets, of which 1 is released in full and 128 are withheld in full.
- *NSC* contains 67 assets, of which 67 are withheld in full.
- *OA* contains 40 assets, of which 7 are released in full, 2 are withheld in part, and 31 are withheld in full.
- *WHO* contains 2,418 assets, of which 74 are released in full, 3 are withheld in part, and 2,341 are withheld in full.
- *Email_Presidential 2016.01.01_2016.03.31* contains 3,114 assets, of which 625 are released in full, 50 are withheld in part, and 2,439 are withheld in full
