This FOIA primarily contains email correspondence, mostly regarding scheduling requests and David Lane's nomination as Ambassador of the United States to the United Nations Agencies for Food and Agriculture.

System of Arrangement

The materials in FOIA 23-53563-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – Obama Presidential Electronic Records

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

Email_Other_From contains 64 assets, of which 8 are released in full, 1 is withheld in part, and 55 are withheld in full.

Email_Other_To contains 122 assets, of which 5 are released in full, 21 are withheld in part, and 96 are withheld in full.

Email_Presidential_From contains 132 assets, of which 10 are released in full, 12 are withheld in part, and 110 are withheld in full.

Email_Presidential_To contains 254 assets, of which 15 are released in full, 28 are withheld in part, and 211 are withheld in full.
