Scope and Content Note

The materials in FOIA 25-57521-F are a selective, not necessarily all-inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 25-57521-F requested all photographs and videos related to Osama bin Laden.

This FOIA primarily contains photographs of President Barack Obama in an interview with Steve Kroft of 60 Minutes in the Roosevelt Room on May 4, 2011; and delivering remarks at CIA Headquarters in Langley, VA on May 20, 2011. There are also photos of the First Lady participating in an interview with Steven Colbert in New York, NY, on April 11, 2012.

System of Arrangement

The materials in FOIA 25-57521-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – Obama Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House’s electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
