Scope and Content

The materials in FOIA 22-24512-F are a selective, not necessarily all-inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 22-24512-F requested photographs of Christmas décor at White House Christmas parties from 2010 through 2014, including table décor and Christmas trees.

This FOIA primarily contains photographs from the press previews and holiday arts and crafts with children of military personnel, tours, and holiday receptions for the public and staff for those years.

System of Arrangement

The materials in FOIA 22-24512-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – Obama Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
