FOIA 22-29678-F requested Pete Souza photos of Richard Thomas and his students from Queen Elizabeth Public School in Ottawa, Ontario, in June 2016. President Obama addressed the House of Commons on Parliament Hill in Ottawa. Thomas and his students were on the front steps.

This FOIA primarily contains photographs of Prime Minister Justin Trudeau of Canada and his wife, Sophie Grégoire-Trudeau greeting President Obama upon arrival; greeting children; and greeting the welcoming party at Parliament Hill in Ottawa, Canada, on June 29, 2016.

Records responsive to this FOIA were found in these collection areas –Obama Presidential Electronic Records

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
