USDA signed a FY 2010 \$30.4 million grant Food for Progress (FFPr) with Winrock International, a U.S. based non-governmental organization (NGO, for Pakistan. The grant will supply Winrock with 20,900 metric tons (MT) of soybean oil to be sold in Pakistan. Proceeds generated from the sale of the soybean oil (estimated at USD \$14 million) will be used to implement the Pakistan Agriculture and Cold Chain Development project (PACCD). The PACCD will help modernize agriculture in the Baluchistan Province of southwest Pakistan, moving it away from the current low-value farming model to one premised on quality production linked to urban markets. By linking private sector participants in the perishable goods value chain with new cold chain facilities and enhanced production techniques, the project will improve food quality and supply, support higher farm gate prices for producers and ensure a higher value end product to consumers. PACCD will emphasize private sector development and will work with both newly emerging and already commercially viable enterprises able to capitalize efficiently on new market chain linkages and commercial opportunities. Implementation of international phytosanitary and regulatory standards will move current horticulture, fruit and fish production in Baluchistan toward larger, more profitable markets. The Winrock PACCD project will improve farmer and fisher folk production practices and prices while working with all actors along the value chain to reduce post harvest losses and improve product quality for the end user.
