The distribution of Recovery Act funds to provide Americans with safe water dominated Recovery Act news this week in twelve states from Maine to Hawaii.

Another emerging theme this week was states, including Arkansas, Louisiana, and Michigan, using Recovery funds to improve public safety by retaining police officers and buying much needed police cars and fire trucks. Colorado broke ground on its first construction project, which came in 30 percent under the original estimated cost. *great where are we on these extra \$.*

One noteworthy job creation story came out of Perry County, Tennessee, which has more than 25 percent unemployment, the highest in the state, and will see the creation of 300 new jobs and a summer youth employment program thanks to funds from the Recovery Act.

In addition, the U.S. Department of Health and Human Services announced this week that Indian Health Services will release \$500 million for improvements for Indian health.

- **Rural Jackpot, NV, Will Use Stimulus Funds to Remove Uranium from Drinking Water.** "The Jackpot Advisory Board approved applications for financing water projects with stimulus funds and for matching funds from the U.S. Department of Agriculture Rural Development on Thursday evening. Elko County Public Works Director Lynn Forsberg said that based on Jackpot's ranking and the amount of federal stimulus available, Jackpot will receive only \$1.9 million instead of \$3.3 million originally projected for its projects... The new projections designated \$846,000 to reduce uranium in a drinking water well and \$1.1 million for the wastewater treatment project...He also said the treatment plant is expanding to an additional capacity of 100,000 gallons per day." - **North Dakota Will Receive \$18.3 Million In Recovery Funds For Water Improvement Projects; Senator Dorgan: The Ability To Get This Funding Is Going To Move Up Anywhere From Three To Four Years The Delivery Of Good, Quality Water To A Lot Of Families In This Region."** "The \$5.86 million in federal stimulus funds for North Central Rural Water Consortium projects comes as relief to residents in western McLean and southern Ward counties. 'We need something a whole lot better than this,' Sen. Byron Dorgan,

D-N.D., said Friday as he held up a jug of dark brown liquid from a well in the Ryder-Makoti area...Dorgan held a news conference at the Minot airport Friday to talk about \$18.3 million in the federal economic recovery package for water projects across North Dakota. Dorgan, who chairs the Senate Energy and Water Appropriations Subcommittee, said the projects will create jobs while speeding up the time table for construction of water projects. 'It's a big investment but it's going to produce assets for decades and decades ahead,' he said. 'The ability to get this funding is going to move up anywhere from three to four years the delivery of good, quality water to a lot of families in this region.' [Minot Daily News, 5/16/09]

- **Rural Communities In Arkansas Will Receive Stimulus Funds To Buy Police Cars, Fire Trucks, And Other Needed Safety Equipment.** "Rural communities across Arkansas will receive a total of \$1.45 million to buy police cars, fire trucks, and other needed safety equipment, according to an announcement Tuesday by the state's congressional delegation. The funds are provided by the American Recovery & Reinvestment Act of 2009, which Congress passed with their support and the President Obama signed into law earlier this year. 'More than \$1 billion in economic recovery funds already have flowed into Arkansas, helping build roads, repair schools, and provide health care, among other critical priorities,' said Sen. Blanche Lincoln, D-Ark. 'These latest funds will provide our communities with much-needed resources to help keep Arkansans safe.'" [Arkansas Business, 5/19/09]
- **Colorado's First Road Project Funded By Stimulus Funds Will Break Ground Tuesday, 30 Percent Under Estimated Cost.** "Colorado's first road project paid for with federal stimulus money will break ground Tuesday morning. Aggregate Industries-West Central Region Inc. in Golden won the contract in early April to resurface Bellevue Avenue between Federal Boulevard and Santa Fe Drive. The contractor bid \$407,407 for the project, about 30 percent under the estimated cost from the Colorado Department of Transportation. Mike Altergott, an estimator with Aggregate Industries, said in early April that the project would probably have between 12 and 20 people working on it. Gov. Bill Ritter will join federal and state officials to unveil signs to identify road projects done with money from the American Recovery and Reinvestment Act. Colorado expects to get about \$500 million in stimulus money for road and bridge projects." [Denver Business Journal, 5/18/09]
- **Perry County, Tennessee, Which Has 25 Percent Unemployment, Will See 300 New Jobs And A Summer Youth Employment Program Thanks To The Recovery Act.** "Tennessee Gov. Phil Bredesen announced a plan on Friday that would bring 300 jobs to Perry County, which has one of the highest unemployment rates in the nation. With nearly 760 unemployed residents, Perry County has had the highest unemployment rate in Tennessee since December 2007...Located about 70 miles southwest of Nashville along the Tennessee River, the county had an unemployment rate of 25.4 percent in March, the fourth-highest rate among U.S. counties. The new positions include government and

private sector jobs that will be funded by the American Recovery and Reinvestment Act and other federal funds through September 2010. Bredesen said he wants to use as much as \$400 million in the stimulus money to fund the new jobs. Compensation for the jobs will range between minimum wage and \$15.85 per hour, depending on the employer, type of job, education and training requirements. 'This is extremely important to Perry County,' said Perry County Mayor John Carroll. 'We've had situations (in families) where both mother and father are out of work.' Along with the 300 new jobs, up to 200 Perry County residents between the ages of 14 and 24 will be eligible for the Summer Youth Employment Program. The statewide program, also funded by Recovery Act dollars, provides summer jobs and training opportunities to low-income residents. Nearly half the county's work force of 3,000 worked in the auto industry in 2000. Today, that's down to less than 5 percent. In just the last year, two of the largest employers in Perry County have shed close to 800 auto parts jobs. Fisher & Co. moved its operations to Mexico in September while Bates Acquisition LLC, which makes plastic and rubber hoses for automobiles, has also laid off hundreds."

- **Indian Country Will Receive \$500 Million To Improve Health Care Facilities And Services.** "The U.S. Department of Health and Human Services announced that IHS will release \$500 million for improvements in Indian health in the American Recovery and Reinvestment Act of 2009. 'These Recovery Act funds will provide critical assistance to American Indian and Alaska Native communities,' said IHS Director Yvette Roubideaux. 'These funds will help improve health care, create jobs and make our Native communities stronger.' The Recovery Act funds are to be expended as follows: \$227 million for health facilities construction, \$100 million for maintenance and improvements, \$85 million for health information technology, \$68 million for sanitation facilities construction, and \$20 million for health equipment that will improve health care in Indian country. The Recovery Act health facility construction funds will be used to complete the construction of the new IHS Eagle Butte Health Center in Eagle Butte, S.D. and the Norton Sound Regional Hospital in Nome, Alaska. The Eagle Butte Health Center will serve approximately 9,300 American Indians residing on the Cheyenne River Reservation. The facility will replace the existing Eagle Butte IHS Hospital which, at approximately one-third the size of the new facility, is stressed to meet the needs of the entire service population...Finally, Recovery Act funds will be used to purchase more than 200 pieces of medical equipment, including 35 ambulances and 10 Computed Tomography scanners, all of which will contribute substantially to patient care. Other equipment to be purchased includes cardiac monitoring equipment, equipment for integration of electronic patient records, blood chemistry analyzers, dental equipment, emergency defibrillators, and X-ray systems, among other items. The equipment will be distributed across 24 states." [Indian Country Today, 5/18/09]
