**WHITE HOUSE OFFICE (WHO)**

**Text Message Executive Order**

M&A is working with the General Counsel's office at the Department of Transportation regarding the Executive Order entitled *Federal Leadership on Reducing Text Messaging While Driving*. Each federal agency, pursuant to the Executive Order, must put in place guidelines and policies that enforce the standards laid out in the Executive Order. An attorney at DOT is heading up the effort to coordinate the drafting of guidelines for each federal agency to adopt or revise to fit its particular situation or previously established provision. We expect information from DOT's attorney in the next couple of weeks and will finalize EOP's guidelines well in advance of the December 30, 2009 deadline.

**Annual Report to Congress**

White House Personnel completed its first draft of the 2009 Aggregate Report and submitted draft talking points, along with a comparison of data from the last 17 years for M&A to review. The Aggregate Personnel Report is a comprehensive accounting of staff in the White House Office, the White House Executive Residence, the Office of the Vice President, the Office of Policy Development, and the Office of Administration employed during the previous Fiscal Year: October 1, 2008 through September 30, 2009. Only numbers are reported, no names or titles of staff are included. The report is required to be submitted to Congress once annually no more than 60 days following the end of the Fiscal Year. The report is also required to be made available to the public. The Press and Communications shops will review the report prior to submitting to Congress.

**List Tracking Technology Solution for Social and Other Offices**

M&A is working with OCIO to roll out a software application initially for use in the Social Secretary's Office. This software will enable key staff in the First Lady's Office and the COS's Office to more easily identify and track who has been invited, who attended, and most importantly, who has been potentially overlooked on an invitation list. The software should also assist the Social Office manage the volume of activities and guests during the heavy holiday

activity. We are piloting this tool and monitoring its usefulness, after which we will make available to other offices within the White House.

### **White House Operations**

White House Ops is working with the GSA and Executive Residence staff in preparing to decorate the various buildings for the upcoming Holidays. Decorations will be hung on the EEOB starting next Friday, November 27, and the Residence is set to begin decorating two days later.

Additionally, this office is coordinating with both the Residence Staff and the Office of National AIDS Policy (ONAP) for **World AIDS Day** on December 1. An AIDS Ribbon will be hung at the North Portico on that day and we are planning to display some panels from the **AIDS Quilt** in both the EEOB and NEOB on December 1 as well.

Finally, WH Ops has coordinated with FLOTUS Office to partner with *Toys for Tots* for the Holidays. The program will run from November 30 – December 18, 2009.

### **Miscellaneous**

Due to the busy legislative calendar, we have postponed our planned All-Staff Conference Call. We are now looking at conducting this call on December 5, 2009.

## **OFFICE OF ADMINISTRATION (OA)**

OA is in the final selection process for the new Chief of **Office of Security and Emergency Preparedness (OSEP)**. My deputy, Henry De Sio, and OA Director, Cameron Moody, are meeting the two finalists today and I will meet with the final candidate prior to the position being offered. We expect this process to be wrapped up by November 30, 2009.

The **Office of the CIO** continues its work to modernize and stabilize the network. New fiber is being pulled into the West Wing network to facilitate the upgrade in systems there. The CIO's office also reports that nearly 700 secure mobile workstations have been distributed to staff in WHO, OVP, OMB, OA, OSTP, and CEQ. White House Office is nearly complete.

As you know, the volume of correspondence received by this Administration is at record numbers. With the volume of work so great in WH Correspondence, it is important that we develop tight, efficient systems to maximize work product. To assist in this, I authorized WH Ops to procure a new content management system, *Symplicity*, prior to the end of last fiscal year. The system will be able to "read" incoming email and snail mail (after it has been scanned) and, using keywords and phrases, automatically sort them into batches and assign them to the appropriate staff member. Once the staff has the batch, they can respond to the letters by mixing and matching pre-approved responses to create a more personal response to the letter. All outside coordinated emails and letters (those that are identical and sent by individuals belonging to an organization) can be responded to automatically. This system will also streamline and automate the approval process for new letters and text through the Correspondence team.

*Symplicity* is working with Correspondence and OCIO right now to develop and implement this system. It will take some time to program before being rolled out (approximately six months).

In the meantime, I have asked **OA's Training and Development Office** to assist the WH Correspondence Office with an evaluation of staffing plans, training needs and other systems. Mike Kelleher, Director of WH Correspondence, has been very receptive to the assistance being provided by WH Ops and OA.

This week's American Recovery and Reinvestment Act success stories highlighted support for health providers, training for green jobs, and assistance to early childhood development.

On Tuesday, HHS Secretary Sebelius announced \$1.2 million in Recovery Act funds to support health professions faculty from disadvantaged backgrounds to repay their student loans. In Delaware, the Wilmington VA Medical Center will use Recovery Act funds to support an outpatient clinic for its Women's Health program and its Operation Iraqi Freedom/Operation Enduring Freedom program.

On Wednesday, Labor Secretary Solis announced nearly \$55 million in grants to help workers find jobs in green industries. Local stories reported that Pennsylvania, Delaware and New Jersey will all train new workers. Vermont will lead an eight-state consortium to create a "National Green Jobs Bank" to provide green job listings and career training information.

This week's stories also highlighted assistance to early childhood development programs. In Santa Cruz, Stimulus funding will add 130 new spots for the Early Head Start program and 44 for Head Start. In New York, ARRA funds will be used to expand from 45 to 95 the number of infants and toddlers that Sullivan County Early Head Start serves.

- **Secretary Sebelius Announced Recovery Act Funded Awards To Support Health Professions Faculty From Disadvantaged Backgrounds to Repay Their Student Loans.** "HHS Secretary Kathleen Sebelius today announced awards totaling nearly \$1.2 million to help health professions faculty from disadvantaged backgrounds repay their student loans. The funds are part of \$500 million appropriated to HHS' Health Resources and Services Administration (HRSA) by the American Recovery and Reinvestment Act (Recovery Act) to address workforce shortages and encourage greater diversity in the health professions. 'These funds will help place faculty from disadvantaged backgrounds in critical teaching positions in colleges and universities where they can serve as mentors and role models for students,' said Secretary Sebelius. 'By helping faculty repay their loans, we make it possible to keep them in the

classroom where they can make a tremendous difference for the next generation of health professionals," said HRSA Administrator Mary Wakefield, Ph.D., R.N. The awards are made through HRSA's Faculty Loan Repayment Program, which is a loan repayment program specifically for health professions graduates from disadvantaged backgrounds who agree to serve as faculty at an eligible health professions college or university for a minimum of two years.
