Call sheets being forwarded to you shortly. Situation now resolved, as shooter confirmed deceased and bomb techs have given clearance (nothing found on subject). Below provides an overview of shooting incident:

Situation: At approximately 11:15 a.m. on 10/21/2012 CDT, a lone gunman entered the Azana Salon in Brookfield, Wisconsin, and began shooting at employees and patrons of the salon. Three individuals are confirmed deceased, including subject's estranged wife who worked at salon, and four others are wounded. The subject ultimately went upstairs in the salon, and is believed to have died of a self-inflicted gunshot wound. At this time, the subject has been identified by his driver's license photograph.

There was a history of domestic violence between the subject and his estranged wife. The subject was arrested in the past week for slashing his estranged wife's tires. There were no active warrants for the subject at the time of the shooting. Investigation has determined that the subject was dropped off at the scene by a taxi.

Person of Interest/Subject:

Subject/shooter has been identified as Radcliff F. Haughton, M/B, DOB 12/17/1966.

Gunman was former Marine. Four dead including ex-wife and shooter. Four in hospital, two serious. Handgun(s) used.

According to latest from FBI:

Brookfield PD just advised what they thought they had as a suspect was unconfirmed movement on the second floor of the building.

They CANNOT confirm the subject is cornered. His residence in Brown Deer is surrounded and Be On The Lookout (BOLO) notices are out, but the subject is not/not confirmed contained at this point.

One small IED (described as a small propane tank) was described by initial SWAT responders as "detonated" in the spa (NFI). SABC and local bomb squad is enroute.
