I propose:

I have also learned that most part-time jobs are during my regular part-time job hours and are getting harder to find. I recently learned that a full-time job I applied for had 62 applicants. The applicant pool was very competitive and almost all were part-timers seeking full-time work. Clearly, I'm not the exception.

As for health insurance, I have used up my savings and small inheritance paying for health insurance. As of September 1st, I am part of the uninsured. I was told that in October I'll learn what my options are under the Affordable Care Act. In January, I'll be able to purchase the option of my choice. If I do not purchase one, I'll be fined. The fine will be small at first but increase each year until the fine will equal the cost of insurance. If I cannot afford health insurance, how will I afford the fines you gentlemen have imposed on me?

I have been repeatedly told and believed that I would benefit from this law. I have yet to see any benefit. The Affordable Care Act appears to be "The Government Doesn't Care Act." But the Federal Government appears determined to make me pay for something that will not help me and will make me as bankrupt as it is. If you cannot help me, can you at least stop hurting me?

I heard that the IRS will not be running our new health care system. This truly is a move in the right direction. Do any of you go to your CPA for your medical problems?
