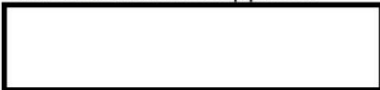

I want to start by saying I'm [redacted] I'm a Vietnam era vet,
West Point graduate class of [redacted] I have served my country and I consider myself very
patriotic. [redacted] The purpose of my
letter is to thank you personally for your recent actions regarding our war with Al Qaeda,
and to say you have my undying respect and gratitude.

As all Americans I watched with fascination as events unfolded surrounding the
death of Bin Laden. You were very gracious and quick to give credit to all the agencies
and departments involved. True they did their job. However, I don't want to thank them, I
want to thank you. On all points in my estimation you made the right calls. To authorize
the raid, to not tell Pakistan, to select the Navy Seals, to kill rather than capture, and to
bury at sea. All this required courage and guts. Even your speeches afterwards were

politics aside, and gave credit to a man who made us all proud. Duty, Honor, Country is
what they preach at West Point and your actions couldn't have said it better. Thanks.
