Subject: Congressional Week Ahead

WEEK OF SEPTEMBER 10 – THE SENATE AND HOUSE ARE IN SESSION

Congress returns to Washington this week. Both Chambers are expected to be in session for approximately eight legislative days prior to the November election. A six-month Continuing Resolution (CR) is the one item that Congress must pass during this work period.

On Monday, the Senate will convene to vote on a judicial nomination. Later in the week, the Senate will consider the Vets Jobs Corps Act. Leadership staff have advised that there will be more clarity on the September floor schedule after the Democratic Caucus Meeting on Tuesday. The Foreign Relations Committee will meet on Wednesday and Thursday to consider the nominations of Joseph Macmanus (IAEA), Sharon Villarosa (Ambassador to Mauritius and Seychelles), Walter North (Ambassador to Papua New Guinea), Stephen Mull (Ambassador to Poland) and Dawn Liberi (Ambassador to Burundi).

The House will also convene tomorrow and consider the following items: FISA Amendments Act Reauthorization; the CR; the National Security and Job Protection Act (Sequestration-related measure offered by Representative Allen West (R-FL)); the Vietnam Human Rights Act; a Vietnam human rights resolution; North Korea Refugee Adoption Act; and a Sri Lanka internal rebuilding resolution. Several Armed Services Subcommittees will hold hearings this week on building partner capacity programs, shipbuilding, operational contracting support, F-22 pilot issues, Y-12 intrusion (Energy Deputy Secretary Poneman testifying); audibility challenges and voting issues. The Foreign Affairs Committee and Subcommittees will review issues relating to the South China Sea, treatment of Chinese dissidents, the Haqqani FTO (no USG witnesses testifying), Camp Liberty and strategic operations in Africa. The Committee will also markup H.R. 6313 (To promote peaceful and collaborative resolution of maritime territorial disputes in the South China Sea and its environs and other maritime areas adjacent to the East Asian mainland). Several Homeland Security Subcommittees will also hold hearings on transportation security in the wake of 9/11, cyber security, emergency preparedness and Fort Hood. The House Intelligence Committee will meet this week to discuss Huawei and ZTE.
