Hi, Cora! Looping back on your question, I can now tell you that at the President's direction, the U.S. government has looked into the facts of the 2001 Dasht-e-Leili massacre and we have concluded that no American troops were involved in this incident.

For questions about the role of any Afghan citizens, we'd refer you to the Government of Afghanistan. As we have in other cases, including those documented in our annual human rights reports, we urge Afghanistan to work through its legal frameworks and the Afghan Independent Human Rights Commission to uphold human rights principles. In addition, we have long said that the future of Afghanistan is up to Afghans, and we support an Afghan-led process of peace and reconciliation to help end decades of war.

Question for you: back in '09, President Obama pledged to order a review of the alleged massacre of Taliban prisoners in Afghanistan in November, 2001. (Generally known as the Dasht-e-leili massacre.) He said so in response to a New York Times report that no investigation had been allowed to proceed under the Bush administration.

It seems that since then, nothing more about this has been released to the public. Did the President in fact order a national security council review of this? Was an official investigation launched? To what end?
