FOIA 22-16572-F [1] requested all photos and videos from White House and Camp David movie screenings.

This FOIA primarily contains photographs of these movie screenings at the White House: “Slumdog Millionaire” on April 24, 2009; “Julie and Julia” on July 20, 2009; “The National Parks: America’s Best Idea” on September 17, 2009; “Where the Wild Things Are” on November 5, 2009; “Nuclear Tipping Point” on April 6, 2010; “The President’s Photographer” on November 11, 2010; “Thurgood” on February 16 and 17, 2011; “The Help” on July 27, 2011; “The Muppets” on November 22, 2011; “Red Tails” on January 13, 2012; “To Kill a Mockingbird” on April 5, 2012; “Men in Black 3” on May 25, 2012; “Lincoln” on November 15, 2012; “Beasts of the Southern Wild” on February 13, 2013; “42” on April 2, 2013; “Mandela: Long Walk to Freedom” on November 7, 2013; “The Inevitable Defeat of Mister and Pete” on January 15, 2014; “The Monuments Men” on February 18, 2014; “Selma” on January 16, 2015; “Star Wars: The Force Awakens” on December 18, 2015; “Before the Flood” on October 3, 2016; “We Will Rise: Michelle Obama’s Mission to Educate Girls Around the World” on October 11, 2016; and “Star Wars Rogue One” on December 16, 2016. This FOIA also contains footage by the White House videographer at screenings of the films “Nuclear Tipping Point” at the White House on April 6, 2010 and “Red Tails” at the White House on January 13, 2012.

System of Arrangement

The materials in FOIA 22-16572-F [1] are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – Obama Presidential Electronic Records, and White House Communications Agency

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House’s electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

White House Communications Agency records are processed at the folder/videotape level. While this method maintains folder/videotape integrity, it frequently results in the incidental processing of videotapes that are not wholly responsive to the subject area.
