FOIA 22-18731-F requested photographs with Erica Pincus, who worked for the Domestic Policy Council's Office of Social Innovation and Civic Participation, Office of Science and Technology Policy, and the White House Office of Social Innovation.

This FOIA primarily contains photographs President Obama took with Erica Pincus and her family around the time of her departure from the White House

### **System of Arrangement**

The materials in FOIA 22-18731-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – Obama Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
