Subject: Interagency Security Classification Appeals Panel decision on the second classification challenge appeal filed by Russ Swift, Bath Iron Works

The Interagency Security Classification Appeals Panel (ISCAP), established under section 5.3 of Executive Order 13526, entitled "Classified National Security Information," has reached its decision on the eight videos concerning ship silencing techniques within the second classification challenge review appeal filed by Mr. Russ Swift of Bath Iron Works. Another document in this appeal, entitled, "NAVSEA 0948-LP-063-0910, Noise Isolation Pipe Hanger Design Handbook," dated November 1969, had been declassified by the Department of the Navy prior to review by the Panel, as expressed in a letter (Ref. NAVSEA Letter 9073, Ser SEA 05P/067) from the Commander, Naval Sea Systems Command to the ISCAP, dated February 5, 2010.

The ISCAP voted unanimously to uphold the classification at the Confidential level of four of the eight videos and to overturn the classification of the other four videos by removing the classification by compilation determination. This decision does not overturn the decision of the Department of the Navy made during the deliberation process, as expressed in a letter (Ref. NAVSEA Letter 12345 Ser 05P/C295) from the Commander, Naval Sea Systems Command to the ISCAP, dated August 3, 2010. As a result, this decision of the ISCAP does not require a 60-day period during which an agency head may appeal the decision to the President. It is the responsibility of the Department of the Navy to provide appropriate instructions to the appellant for the proper declassification and safeguarding of the records at issue in this appeal and to provide the ISCAP with a copy of those instructions.
