

Upon review of your letter dated October 14, 2010, concerning a classification challenge you filed within the National Security Agency, I have determined that the Interagency Security Classification Appeals Panel (the Panel) cannot accept your appeal. Section 1.8(c) of Executive Order 13526, "Classified National Security Information," states that, "Documents required to be submitted for prepublication review or other administrative process pursuant to an approved nondisclosure agreement are not covered by this section." Appeals of classification challenges for documents submitted for prepublication review can no longer be accepted by the Panel.
